By-Laws on Membership:

- Membership of the society shall consist of (1) Ordinary Member (name appear on a Methodist Church roll) & (2) Associate Member (Non-Methodist).
- Applicants must (A) have attained the age of 16 years, (B) be citizens of/or residents in Singapore, (C) be in the opinion of the board of good character, (D) not be mentally disabled, (E) not be an undischarged bankrupt & not have a conviction standing against him for an offence punishable with imprisonment.
- The Board shall have power to approve or reject any application without assigning any reason thereof. Applicant may appeal in writing to a general meeting of the society upon rejection.
- In case of changes to nominee, every member may in writing nominate one person to whom his/her share, interest & all other sums due shall be paid upon his/her death.
- Membership shall cease by (A) resignation (with 3 months' notice), (B) reasons of insanity, (C) permanent removal of residence beyond Singapore, (D), expulsion by the board, (E) conviction of an offence punishable with imprisonment, (F) bankruptcy, (G) death or (H) disqualification under our by-laws.
